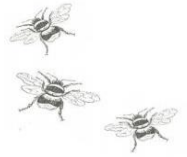

Helping each other in the pandemic

We live in two realities in Oxford today: the world of people now relieved that the end of the pandemic may be in sight, and the world of people who have been thrown into crisis. "Mutual Aid" is the redistribution of resources from people who have more than they need, to people who have less than they need.

Oxford Mutual Aid (OMA) did not exist until March 2020, but was created by people drawn from religious groups, trade unions and immigrant communities who realised that COVID-19 was going to make worse already strained access-to-food, the poverty crisis in Oxford, and the pandemic would further stress badly overstretched social services.

OMA focuses on people who have fallen through the cracks in the existing aid infrastructure, including people forgotten somewhere in bureaucracy. As of January, OMA is now probably supporting over 1500 people in Oxford.

- Regular food parcel and supply support to 223 households, comprising of 672 people (378 adults, 258 children, and 36 babies)
- Supporting 65 households with new and expectant mothers, supplying them with formula milk, nappies, rash cream and more.
- Over 216 emergency food parcels a month, going to an average household of at least 2 people
- Ongoing support to 25 households who require support collecting prescriptions, doing shopping, etc
- The Kitchen Collective is providing re-heatable meals to a minimum of 145 households each week

All of these efforts represent people organising together to achieve what is needed, and have shown this "direct democracy" is especially effective in crisis. Those of us who currently have more than we need might consider contributing via OMA to people who have less than they need.

Improving our environment

The River, the Kidneys and Astons Eyot have been a life-line for many during lockdown and led to heavy use. We identified the need for more bins and a bench.

Bench for the Recreation Ground



A number of residents have pointed out there's not anywhere to sit down at the Meadow Lane Rec, with options being sitting on the grass or balancing on a rotting tree trunk. In a poll carried out last year, many residents indicated they would like to see a park bench in the Rec. If we install a bench, we can make a difference for people

who are mobility disabled, post-surgery, recovering from illness, or just plain tired and want to sit and daydream. The Council do not have the funds for this, but will arrange for a bench if IFRA can pay for this.

We have a good start. IFRA can provide up to £300, thanks to the Open Gardens donation and IFRA is grateful to Property Care for their £200 donation towards the bench.

Field next to the Scout Hut

This was heavily used during lockdown, resulting in a litter problem. The owners have put notices up restricting use. The field is owned by the Oxford Preservation Trust and leased to the Scouts. IFRA is in discussion with the Trust about how access to the river for local people can be maintained without impeding the Scouts.

Bins in Meadow Lane

We have a costing from the Council, who do not have the funds to pay for them. IFRA hopes to raise £450 for them through crowdfunding.

Planning

This sub group monitors planning applications submitted to the Council that affect the area and picks up problems where planning regulations are broken. This year we have supported residents with problems with the Convent redevelopment and issues arising with houses in multiple occupancy (HMOs) and related antisocial behaviour. Noise and antisocial behaviour

Lockdown has been stressful for all of us, occasional loud music or noise we can expect and tolerate but regular noise and parties can cause great distress to the neighbours. If talking to your neighbours does not work, you can contact the Out of Hours Noise service in the City Council - 01865 249811 or email saferoxford@oxford.gov.uk describing the noise nuisance.

You can download The Noise App free from your Apple and Android app store. Your noise recording is sent directly to the City Council to investigate during office hours.

No Cold Calling Zone

Thames Valley Police and Neighbourhood Watch have had many reports of dubious and occasionally threatening salespeople, often known as Nottingham Knockers. They seem to target vulnerable people living alone. It is possible to request a No Cold Calling zone to try and prevent such activities. After a discussion on Facebook, most people welcomed the idea, though there were concerns that this might affect legitimate fundraising by charities.

IFRA has put in an application for Iffley Fields to be a No Cold Calling Zone. Trading Standards will look at the scale of the problem and canvass residents' views before action is taken.

Access to the River

The new IFRA Waterways subgroup was set up in June to look at how we can improve access to the waterways, balancing the need for recreation and protecting wildlife.

Lockdown has highlighted the need for safe swimming areas. There has been particular concern about the pollution from Shire Lake Ditch (alongside Aston's Eyot from the Cherwell to the River). IFRA has contributed to some wins in joint working this year. The IFRA Waterways Subgroup are supporting the Swimmers against Sewage group, and Friends of Aston's Eyot and other residents to persuade the City Council to support a campaign to make the Thames and the Cherwell within the City to have designated "bathing water" status, thus safeguarding it from sewerage pollution.

We are delighted that the City Council has applied for safe swimming status for the Thames and the Government has just announced that all water companies are to provide year-round, real-time data on sewage discharge. This should help us know if the water is safe.

Wood burning stoves and our health

Many residents have reported breathing difficulties as a result of wood burning domestic fires in our streets. Iffley Fields is in a Smoke Control Area. This means that only authorised fuel can be used, except in some wood burning stoves which meet Government standards and are exempt. Contravention can lead to a maximum fine of £1000. More information can be found on the City Council website.

Recent research has shown the damage to health of pollutants such as particulate matter. In the UK, the single biggest source of this type of air pollution is domestic coal and wood-burning. This issue will be discussed at the AGM.

Trialling a kids' football pitch at Meadow Lane Rec

IFRA first submitted a proposal to the Council for chalking up the football pitch in 2019 as a part of a strategy for regenerating the area, including possibly an outdoor gym and a fenced-off dog-free area for younger children to run around. Communication with local clubs revealed unmet demand for informal pitches when lower lying pitches are flooded or waterlogged,

In spite of the support of Councillors, the proposal met with resistance from Council. Our original proposal has shrunk to a 3-month trial of a 55 x 36.5m pitch without goal storage for general use. But this has fared no better at the Council, which does not think the site is appropriate for "formalised" football nor a priority for them.

IFRA Finances

IFRA's funds come from donations, such as from Open Gardens and the Chester. In 2020-21 we spent £66 on printing the newsletter and flyers and £76 on flyers and safety equipment for the Safe Space Event. The balance on 31 January 2020 was £810. In addition, we hold £700 on behalf of the wildlife trust.
